#### Introduction

This document serves as a commitment to uphold academic integrity within the International Baccalaureate Diploma Programme (IB DP), the International Baccalaureate Career-related Programme (IB CP), and BTEC Level 3 courses at Bateen World Academy. Our goal is to instil a sense of responsibility in students for producing academically honest work and to provide them with the support necessary to prevent any form of academic malpractice.

#### **Understanding and Promoting Academic Honesty at Bateen World Academy**

Academic honesty and integrity are the foundation of any educational institution. Academic honesty is an essential principle of the IB's academic programmes that enhances the organization's credibility and position as a leader in international education. As stated in the IB learner profile, all members of the IB community strive to be principled, "and all students participating in IB programmes are expected to act honestly, responsibly and ethically."

Promoting Academic Honesty is essential because lack of academic integrity undermines the philosophy of any educational programme. Students engaging in academic misconduct miss the **"learning opportunity"**.

Additionally, those who seek to breach the regulations of academic work will find it easy to contravene the conventions in other fields.

All stakeholders in the BWA community believe that the principle of academic honesty should be considered by students as a learning experience and become part of their academic study during and beyond the IB Diploma course of study.<sup>2</sup>

#### **Academic Honesty at Bateen World Academy Refers to:**

- Undertaking research honestly and producing authentic pieces of work
- Always respecting intellectual property by acknowledging all ideas and work of others. Source materials
  may include, along with written texts, visual, audio, graphics, artistic, letters, lectures, interviews,
  broadcasts, maps. Forms of intellectual property include patents, trademarks, moral right and copyrights.
- Showing proper conduct during examinations

#### What is Academic Misconduct?

The IBO defines academic misconduct as "behaviour that results in, or may result in, the student or any
other student gaining an unfair advantage (or a behaviour that disadvantages other students) in one or
more assessment components."<sup>3</sup>

#### Categories of "Academic Misconduct":

**Plagiarism** is defined as the representation, intentionally or unwittingly, of the ideas, words or work of another person without proper, clear and explicit acknowledgment. The use of translated materials, unless indicated and acknowledged, is also considered plagiarism.

**Collusion** is defined as supporting academic misconduct by another student, for example allowing one's work to be copied or submitted for assessment by another.

**Misconduct during an IB examination** includes taking unauthorized material into an examination room, disruptive behaviour and communicating with others during the examination.

**Communication about the content of an examination** 24 hours before or after the examination with others outside their school community is also considered a breach to IB regulations.

**Duplication of work** is defined as the presentation of the same work for different assessment components and/or Diploma Programme requirements.

**Paraphrasing,** this is defined as the restatement of someone's work in another form. In order for it to be allowed, the source needs to be acknowledged.

**Fabrication of data,** this is defined as manufacturing data for an experiment and for mathematical exploration/project <sup>4</sup>

#### **Examples of malpractice:**

- Submitting someone else's work to the IBO
- Copying the work of another candidate
- Allowing a peer to copy your work
- Not acknowledging sources
- Asking another person to write your work
- Fabricating data used in an assignment
- Fabricating CAS records and journals
- Stealing examination material and/or exam papers
- Bringing unauthorized material into the examining room. Examples: *notes, unauthorised software on a graphical calculator, mobile phones*
- Disruptive behaviour during examinations
- Impersonating another candidate
- ANY other behaviour that gains an UNFAIR ADVANTAGE for a candidate or that affects the results of another candidate.

#### Use of Artifcial Intelligence (AI)

Bateen World Academy is committed to the ethical and responsible use of Artificial Intelligence (AI) technologies by students in the pursuit of academic excellence. Whilst the school acknowledges the dynamic and emerging role of AI in education, we are committed to upholding our institution's academic core values and academic integrity principles. See **Appendix 1** for our 'Protocol for Teachers and Policy for Students on the Use of AI (ChatGPT)'.

#### **Consequences of Malpractice:**

Any instance of academic dishonesty (internal) at Bateen World Academy is to result in:

#### First Offence:

This is considered a Level 1 violation, an automatic zero for the work in the case of a first offence. Opportunity to be given to make up the zero grade will be on a case-by-case basis dependent on the severity of the incident. The teacher speaks to the student and incident is recorded on the Engage Day Book. Document is to be collected by the teachers and filed with the IB DP/CP Coordinator. Parents are to be notified.

#### Second Offence:

A Level 2 violation, an automatic zero for the work with the same above specified notifications but there will not be an opportunity to resubmit the work. Additionally, a two-day internal intervention is to be assigned and a meeting of the parents, student, teacher and Secondary School Principal.

#### Third Offence:

A level 3 violation, the student is sent to principal, parents contacted and asked to come into school. Written warning signed by all parties / one day suspension will be considered depending on the severity of the case.

#### **IB Sanctions**

IB offical sanction are outlined in Appendix 2, as per the IBO Academic Intergrity Policy 2019 (appendix 2.2), which details infringements by a student and the level of penalty that may be applied by the IB.

#### **Monitoring Sanctions and IB Monitoring Practices**

S. Marsden (IB DP/CP Coordinator) is the named person that monitors the process that the school takes to ensure that sanctions are fully applied and IB Academic Honesty guidance which reflects the school's academic policy is fully adhered to.

IB monitoring practices<sup>5</sup> additional include:

- quality assurance checks of all available pieces of work in IB systems for plagiarism
- quality assurance checks of all available pieces of work in IB systems for overlap in content
- check of response patterns to examination papers, including multiple-choice questions.

#### **External Malpractice**

In case of malpractice in work for an external examination/assessment, the school shall notify the IBO and/or BTEC in addition to the above procedures. Given the potential of discrediting Bateen World Academy under such circumstances, the student may also face exclusion.

#### **Prevention of Academic Dishonesty**

To ensure academic honesty, all work submitted for IBDP, IBCP and BTEC will undergo scrutiny for academic integrity using 'Turnitin®'. Teachers will have a responsibility to ascertain that work submitted is wholly the student's own. Students will be introduced to the school's Academic Honesty Policy, educated on acceptable practices, and informed of the ramifications of academic malpractice. Students are also mandated to sign the official IB Declaration, to confirm that all the work they have submitted meets IBO academic honesty standards.

#### The role of the student:

Students must take responsibility for their learning. They are expected to do their own work and to demonstrate honestly, what they have learned.

#### Student's responsibilities include:

- Read, understand and become familiar with the rules of the Bateen World Academy Academic Honesty
   Policy and with all IBO rules and regulations documents
- IBCP and BTEC students must adhere to Pearson Edexcel guidelines
- All work submitted is the student's own work

- All sources are fully and correctly acknowledged including sources taken from websites, audio-visual, emails, photographs, graphs etc.
- When required by teachers and/ or by the DP Coordinator, students must submit their work to be checked via Turnitin.
- Respect internal deadlines
- Make proper use of a citation style. At Bateen World Academy we have adopted the MLA as our primary method of citation
- When submitting his/her work to IB/BTEC examiners, the candidate is ultimately responsible for ensuring that all work submitted for assessment is authentic, with the work or ideas of others fully and correctly acknowledged.
- Before submitting their work to IBO and/or BTEC, students must sign a declaration of authenticity form.
- Be familiar with, and adhere to the Conduct Posters in Exam Hall/Exam settings.

#### The role of the DP and CP Coordinator

- Establish an academic honesty policy, including review process.
- Ensure teachers and students adhere to the school's academic honesty policy.
- Ensure that students understand clearly the IBO/Pearson Edexcel expectations regarding academic honesty and consequences should this be breeched.
- Ensure that the school's academic honesty policy is aligned with IB/Pearson Edexcel expectations and undergoes a periodic review.
- Ensure that teachers, candidates, and legal guardians are aware of IB requirements concerning academic honesty by providing training and IB Academic Honesty Document.
- Ensure candidates and invigilators are provided with relevant information about examination regulations.
- Establish a schedule of deadlines for assignments.
- Plan regular meetings with faculty members to verify that all parties have a clear understanding of IB and
   Pearson Edexcel expectations.
- Ensure that policies and procedures are easily available to all interested parties (teachers, students and their legal quardians)
- Organise regular briefings with student's legal guardians
- Share with legal guardians the aim of the academic honesty policy.
- Ensure everybody understands academic honesty and consequences for IB students if they engage in academic misconduct.<sup>6</sup>

#### The role of the Extended Essay and Reflective Project Coordinator

The Extended Essay and Reflective Project Coordinator has a key role in introducing and developing students understanding of Academic Honesty.

#### Their role includes:

- To introduce the Policy and to give Academic honesty guidance to the cohort through the extended essay and reflective project workshops.
- To provide activities for students to practice referencing and citing accurately (
- To educate students to recognise examples of Academic Malpractice
- To train supervisors and teachers in Academic Honesty for EE and RP
- To act on the reports of academic malpractice raised by EE and RP supervisors as per the policy
- To moderate and review the EE's and RP's to check for Academic Malpractice

#### The Role of Teachers

Teachers are often the first point of contact in guiding students, and recognising Academic Malpractice.

#### Teachers should:

- Be aware of the contents of the Bateen World Academy Academic Honesty Policy and uphold this during their work.
- Talk to students about plagiarism and how to properly conduct a research paper or prepare an oral
  presentation
- Set clear expectations for assignments and provide guidance to candidates on how to correctly cite sources
- Be vigilant for changes in writing style, and in noticing that the student's work is too complex and academic
  and goes beyond the student's ability
- Read the final version and check for authenticity of any work submitted to IBO. (EE, Reflective Project, TOK papers, Internal Assessment, BTEC coursework)
- Although the candidate is ultimately responsible for ensuring that all work submitted for assessment is
  authentic, with the work or ideas of others fully and correctly acknowledged, it is the responsibility of each
  teacher to confirm that, to the best of his or her knowledge, all candidates' work accepted or submitted
  for assessment is the authentic work of each candidate.
- Be role models of academic honesty and integrity
- Follow the guidance in the Bateen World Academy Academic honesty policy should they suspect malpractice.
- To utilize Turnitin to check for authenticity of work.

#### The Role of Parents

At Bateen World Academy we strongly believe in the open communication between teachers, school administration and parents. Parents can play a very important role in supporting and helping their children achieve their full potential and acting with honesty by:

- Read and become familiar with the Academic Honesty Policy and all IBO documents related to the IB
   Diploma rules and regulations
- Supporting teachers and administrations in talking to their children about the importance of academic integrity
- Cooperate with the school in case their child is found to be guilty of malpractice either intentionally, or by inappropriate documentation of sources.

#### **Resources to Support the Policy**

To fully support our commitment to upholding this policy and to ensure the highest standards of academic work among our students, BWA has integrated Turnitin software into our learning management system, ManageBac. Turnitin will be used routinely as a plagiarism detection tool to check student assignments and Internal Assessment submissions for any instances of academic dishonesty. By utilizing Turnitin, we aim to promote a culture of originality and authenticity in academic work, fostering ethical academic practices among our students. Students are regular reminded about their responsibilities to uphold the principles of academic integrity, through the following strategies:

- Academic honesty assemblies
- Student handbook
- Mentoring sessions
- DP and CP lessons

#### **Evaluation**

This Academic Honesty Policy will be reviewed annually and is supported by:

- A firm commitment to continuous improvement in the quality of teaching and learning of students
- The use of continuing professional development (coaching, mentoring, INSET, peer observation)
- The formal and informal monitoring and review processes which are in place (lesson observations, peer observations, work sampling, student voice, analysis of assessment data)

#### Appendix 1: Protocol for Teachers and Policy for Students on the Use of AI (ChatGPT)

#### I. Protocol for Teachers: Addressing Suspected Plagiarism for Internal Submissions

#### A. Identifying Potential Plagiarism:

- 1. Compare the student's writing style in the assignment with their previous work.
- 2. Look for inconsistencies in grammar, vocabulary, or arguments.
- 3. Verify if information provided in the assignment is accurate and relevant.
- 4. Ask students to provide their research notes/annotated bibliography/rough draft.
- 5. Check for unusual formatting or citation styles.

#### **B. Handling Suspected Plagiarism:**

- 1. Discuss your concerns privately with the student without making direct accusations.
- 2. Ask open-ended, probing questions to gauge the student's understanding of the work.
- 3. Encourage the student to explain their research and writing process.
- 4. Allow the student to revise their work if they admit to using ChatGPT inappropriately.

#### C. Preventing Plagiarism:

- 1. Educate students on the appropriate use of ChatGPT and other online tools.
- 2. Implement assignments that require critical thinking and personal reflection.
- 3. Encourage students to discuss their work with peers and teachers throughout the writing process.
- 4. Provide resources on proper citation and paraphrasing techniques.

#### II. Policy for Students: Appropriate Use of ChatGPT

#### A. Allowed Uses of ChatGPT:

- 1. Generating ideas and brainstorming/mind mapping.
- 2. Researching a topic or finding source material.
- 3. Creating an outline or plan for an assignment.
- 4. Seeking inspiration for creative writing projects.

#### **B. Prohibited Uses of ChatGPT:**

- 1. Copying and pasting ChatGPT-generated content directly into assignments.
- 2. Submitting ChatGPT-generated work without substantial editing, critical thinking, or personal input.
- 3. Using ChatGPT to complete the entirety of an assignment.
- 4. Misrepresenting ChatGPT-generated content as original work.

#### C. Consequences of Misusing ChatGPT:

- 1. Verbal or written warning for first-time offenders.
- 2. Plagiarism education workshop.
- 3. Resubmission of the assignment with potential penalties.
- 4. In severe cases, further disciplinary action up to and including suspension or expulsion.

#### **D. Encouraging Academic Integrity:**

- 1. Ask for help from teachers and peers when struggling with assignments.
- 2. Understand and practice proper citation and paraphrasing techniques.
- 3. Use ChatGPT responsibly as a supplementary tool rather than a shortcut.
- 4. Continuously develop your writing, research, and critical thinking skills.
